# AGREEMENTS SIGNED BY THE DIRECTOR GENERAL OF THE **INTER-AMERICAN CHILDREN'S INSTITUTE**

# Submitted by the Delegations of Argentina and Uruguay

# THE DIRECTING COUNCIL.

#### WHEREAS:

Article 9 d. of the Statutes of the IIN empowers the Directing Council to "approve all conventions and agreements concluded between the Institute and international, governmental or non-governmental organizations, notwithstanding the capacity of the Director General to conclude such agreements and conventions ad referendum of the Directing Council";

Article 12.2 of the Rules of Procedure of the IIN empowers the Directing Council to "create as many commissions and working groups as deemed necessary, assign them the different matters included in the agenda, coordinate their work, monitor their development and formulate any relevant recommendation on their performance";
